- **Please be sure to include the following;**
 - Tenure in the rank of warden/superintendent. Be sure to specify years in title and years in corrections.
 - Involvement in Community & Local Organization
 - Participation in National Corrections Organization
 - What has the candidate done to solve problems in the organization?
 - Has the candidate mentored and assisted in the development of others?
 - Outstanding Achievements
 - YOUR PERSONAL VIEWS
- Should the nominee of an agency be selected as Warden of the Year, the agency head will be notified by the Executive Director of NAAWS and the notification of the Individual selected will be the responsibility of the agency head. The Warden of the Year honor is bestowed on the selectee during the summer (August) Conference of the American Correctional Association (ACA). The Agency Head and the person selected are expected to attend a banquet that is put on by NAAWS to honor the person selected for this prestigious award.
- Nominations must be in the Executive Director of NAAWS possession by November 30th or 30 days prior to the Winter (January/February) Conference of the American Correctional Association (ACA) for that coming year.

Dear Director,

The North American Association of Wardens and Superintendents (NAAWS) wishes to solicit your assistance in identifying the most deserving warden/superintendent in North America to receive the Association's distinguished **Warden of the Year Award**. The **Warden of the Year Award** is presented annually to the warden or superintendent who has contributed significantly to the field of corrections during the year. At the mid-winter ACA Conference in Orlando, Florida (January 5-9, 2017) the NAAWS officers will make the selection for the **Warden of the Year** from the recommendations submitted by the state, federal and private agencies. The award will consist of a special plaque which will be awarded at the summer ACA conference. In addition, all nominees will receive special recognition at the summer ACA conference.

The **Warden of the Year Banquet** will be held in Minneapolis, Minnesota at the summer conference of the ACA. This event is the major event of our organization and is always attended by a large number of Commissioners and Directors.

Our organization would also like to solicit your assistance in identifying staff eligible for the NAAWS **MEDAL OF VALOR**. The **MEDAL OF VALOR** is awarded by the President of the North American Association of Wardens and Superintendents (NAAWS) in the name of the NAAWS officers.

Any person, while employed in the field of corrections, who distinguishes themselves conspicuously by gallantry and intrepidity at the risk of his or her life above and beyond the call of duty, may be recommended for this award. **The deed performed must have been one of personal bravery or self-sacrifice so conspicuous as to clearly distinguish the individual above his or her comrades and must have involved risk of life.**

At the mid-winter ACA Conference, the NAAWS officers will make the selection for the **MEDAL OF VALOR** from the recommendations submitted by the state, federal, and private agencies. The award will consist of a medal mounted in a special display case, which will be awarded at the summer ACA conference. I hope you will take this opportunity to recognize any individuals whom you feel are deserving of either of these prestigious awards. Please submit your nominations, describing the reasons why you believe your nominee(s) are deserving on the attached forms (or reproduced format) to me prior to December 15, 2017. We will accept electronic nominations online at naawsonline.org or gloriahultz@rochester.rr.com. We will, however, need verification that the nomination has the approval of the agency CEO.
